### 2.3 Request of Prof. T.G. Rupa to conduct course in Google Sketchup

Prof. T.G. Rupa, Department of Resource Management & Design Application requested vide letter dated 23<sup>rd</sup> December, 2024 for permission to conduct a short course in Google

Sketchup, a 3D software for Under Graduate students of Department of RMDA in the coming semester starting January 2025. This course will be of 20 hours duration and will be held on online mode with a few offline classes. The Advisory Committee of the DIC has approved the course. A fee of Rs.1500/- per student would be charged for the classes. Permission is also sought to issue certificates from the Department of Resource Management & Design Application, Lady Irwin College.

# 2.4 Renewal of work contract of Rakshak Securitas Pvt. Ltd.

M/s Rakshak Securitas Private Limited informed vide letter dated 12.12.2024 that their work contract is expiring on 31<sup>st</sup> December, 2024. The said company has shown its willingness to continue this work contract on the same terms and conditions for a further period of one year. The College Administration vide note dated 16.12.2024 recommended to continue the services of Rakshak Securitas Private Limited for another one year.

2.4.1 Later after going through the terms and conditions of their agreement, the Governing Body approved by circulation the extension of contract of M/s Rakshak Securitas Pvt. Ltd. for a period of one year w.e.f. 01.01.2025 on the same terms and conditions."

### III. FINANCIAL MATTERS

### 3.1 Condonation of three cases of Negative Balance

- (i) The Accounts Department has requested vide Office Note dated 09.12.2024 for condonation of three cases of negative balance as per details given in the said office note. To substantiate the waiver of negative balance, Office Memorandum dated 19.09.2022 issue by the DOPT is enclosed in agenda which says that 'situation wherein recoveries of wrongful/excess payments are impermissible in law where the excess payment has been made for a period in excess of five years, before the order of recovery is issued'.
- (ii) The College is required to pay approximately 25 staff members with interest. Since the interest rate for 2024-25 is yet to be decided, if approved, the final payments be made in March 2024 alongwith interest of 2024-25 to make full and final settlement in these cases (list enclosed in agenda).

- 4.1 Renewal of work contract of M/s Trio Security and Intelligence Pvt. Ltd.:-

- 4.3 Lady Irwin College being a heritage college, has been approached by some communication agencies for short projects. The Governing Body members suggested terms and conditions be drawn and a College committee created for approval."
