I. MINUTES OF THE GB MEETING

II. ADMINISTRATIVE MATTERS

2.1 Approval of Selection Committee minutes

Selection Committee meetings were held on 28-29 November, 2023 (English), 04.12.2023 (Environment Science), 08.12.2023 (Mass Communication), 15.12.2023 (Statistics) and 19.12.2023 (Microbiology) for appointment of Assistant Professors in various Departments. Details of selected candidates were tabled. Candidates who were selected, were given appointment letters and they have joined.

2.2 Appointment of Non-Teaching Staff

Based on the recommendations of the Selection Committee and Governing Body Chairperson, Mr. Virender Kumar was offered the appointment to join as Senior Assistant and he joined the service in the College on 07.12.2023. 2.3 Appointment of Administrative Officer

2.4 Application of Dr. Priti Joshi for grant of Voluntary Retirement from service

Dr. Priti Joshi working as Professor in the Department of Human Development and Childhood Studies submitted her request vide letter dated 12.12.2023 for grant of Voluntary Retirement from College service and requested for relieving on 30th April, 2024. Her Date of Joining on permanent basis is 17.07.1996. Office Note is enclosed at page-11 in agenda.

"The Governing Body accorded approval for the voluntary retirement of Dr. Priti Joshi w.e.f. 1st May, 2024 and relieving after due completion of three month notice period and for sending the papers to the University for fixing pension and other retirement benefits."

2.5 Computer Resource Centre (CRC) Staff Salaries

The two junior staff working in the Computer Resource Centre namely Ms. Kusum Kaushik and Mr. Suraj Sunuwar were appointed for one year period from 07.01.2023 at minimum of basic pay at Level 4 + DA in accordance with University of Delhi Notification No. Estab.II(i)/012/2007/08/2101 dated 12.11.2021.

Their performance is good and it is recommended to renew their appointment for one year.

They have requested vide letter dated 11.12.2023 for renewal of their appointment.

"It was decided by the Governing Body to extend their appointment for one year at Level 4. Their salary to be fixed in accordance with University of Delhi Notification No. Estab.II(i)/012/2007/08/2101 dated 12.11.2021."

2.6 (A) Renewal of Rakshak Securitas (Pvt.) Ltd. Contract

The one year contract of M/s Rakshak Securitas (Pvt.) Ltd. is going to end on 31.12.2023 for providing house keeping services. They have shown their willingness to work under the existing terms and conditions of contract for a further period of one year vide letter dated 30.11.2023. With ongoing recruitment of non-teaching staff, some staff of Rakshak will be asked to discontinue during the next year.

(B) Renewal of Trio Security & Intelligence Pvt. Ltd. contract

The one year contract of M/s Trio Security & Intelligence Pvt. Ltd. is going to end on 14.12.2023 for providing security services. Their contract may be renewed on the existing terms and conditions for a further period of one year.

"The Governing Body approved the renewal of contract with Trio Security & Intelligence Pvt. Ltd. and Rakshak Securitas Pvt. Ltd. for one more year w.e.f. 15.12.2023 to 14.12.2024 and 01.01.2024 to 31.12.2024 respectively on the same terms and conditions. However, in the case of Rakshak Securitas Pvt. Ltd. some of their staff members would have to be reduced consequent to ongoing recruitments in the College."

2.7 Proposal of Central Bharat Sevak Samaj – Vocational Education Courses

We are in receipt of a letter dated 20.09.2023 from Central Bharat Sevak Samaj, which is the National Development Agency constituted by the Planning Commission, Government of India, is imparting Vocational Training Programmes, Skills Development Programmes, Technical and Management Programmes and for which they offered to start these programmes in our institution.

"After detailed deliberations, it was decided by the Governing Body to ask them to make presentation to the faculty sub-group."
