# 2.5 (A) Opening of separate Bank Account for DBT Star College Scheme Grant

Dr. Pooja Raizada and Dr. Aparna Agarwal informed vide letter dated 06.12.2021 that as per the requirement of DBT Star College Scheme, Ministry of Science and Technology e.mail we have to open a fresh savings bank account and link with PFMS for DBT Star College Scheme grant vide their letter dated 25th November, 2021. This should also be implemented with EAT module.

The Governing Body was requested to accord approval for opening of a dedicated savings bank account for DBT Star College Scheme linked with PFMS and EAT. This account will be operated by Bursar and Director as usual.

MOU has to be also signed for receiving further grants. This has been legally vetted and tabled. The Governing Body was requested to accord approval.

#### 2.6 Extension of tenure of Hostel Superintendent

Ms. Sunita Srivastava, Hostel Superintendent has requested for extension of her services vide letter dated 30.10.2021. Her present tenure is till 31.12.2021. Her monthly consolidated salary is Rs.26000/-. She has completed 60 years of age (DOB 26.04.1961). However, the Hostel Committee met on 30.11.2021 and recommended extension for one year to her. The resolution passed by the Hostel Committee to this effect was enclosed in agenda.

It was brought to notice that hostel had abruptly closed in March 2020 and students did not clear their belongings. The hostel clerk, Ms. Madhu has also retired and there is poor continuity.

07.01.2022 till one year on a consolidated salary of Rs.20,976 and DA Rs.208/- per month as fresh contract based on rates given in Govt. of NCT of Delhi, Office of the Commissioner (Labour) dated 11.11.2021. The terms & conditions of her appointment will be same, as contained in her initial appointment letter dated 23<sup>rd</sup> December, 2009 in this new contract. It was advised to advertise for the post."

**2.6.1** Opening of College Hostel, Canteen tender, Hostel tender – The Hostel Committee met on 30.11.2021 and discussed issues related to opening of College Hostel. The minutes of Hostel Committee meeting were enclosed in agenda for perusal of the Governing Body. They recommend that opening mess for small number of students may not be feasible and suggest opening of College canteen who can also provide meals to be purchased directly by students. Meanwhile, pantry facilities may be provided. The hostel fee then will not include mess charges.

Once the students are permitted to stay full strength then hostel mess tender can be opened, and mess charges be charged accordingly.

## 2.7 Computer Resource Centre (CRC) Staff Salaries

The two junior staff working in the Computer Resource Centre namely Ms. Kusum Kaushik and Mr. Suraj Sunuwar were appointed for one year period from 04.01.2021 on a monthly consolidated salary of Rs.21,000/-. They have requested vide letter dated 03.12.2021 for renewal of their appointment.

# 2.8 Family Pension of Dr. Usha Raina

Ms. Anumeeta Raina on 29.10.2021 formally applied for family pension. Her mother was a teacher in College till she retired in 2004. She was a pensioner till death on 8<sup>th</sup> September, 2014. Thereafter her husband drew family pension till his death on 25<sup>th</sup> April, 2021 leaving her alone to fend for herself. She made formal applications with all supporting documents and her affidavits and divorce in Bikaner Court on 31.03.1992.

The papers have been processed vide Handbook on Family Pension under CCS (Pension) Rules 1972 released in January 2020 which are also accepted by the University of Delhi.

The Governing Body was requested to advice on the matter and recommend future action. Meanwhile her pension papers have been sent to DU for fixing pension under 7<sup>th</sup> CPC.
