Madam,

I am directed to refer to the subject as mentioned above and to inform you that on the basis of the inspection report submitted by the visiting experts, permission to conduct the B.Ed Spl. Education (MR) Course has been accorded for the two academic years i.e. 2007-08 & 2008-09 provided that the following shortcomings have been removed before commencement of the course.

1. Proof of recruitment of teaching faculty (core) with evidentiary documents like appointment letters, acceptance letters, their qualification and professional qualification, RCI registration number. The teaching core faculty must have the prescribed qualifications as per norms.
2. Library needs to be strengthened by procuring more prescribed books as per B.Ed (MR) syllabus. Evidentiary documents in support of the procurement of Books to be submitted.
3. CBR activities needs to be strengthened.

Affiliation from University & NOC from State Govt. have not been submitted so far as requested vide Council letters dated 24-5-2006, 15-6-2007, 23-8-2006 & 15-9-2006. Recognition fee of Rs.10, 000 may kindly be remitted at the earliest.

In the light of above, you are requested to submit the above said required documents at the earliest so that the Certificate of approval may be issued accordingly. Compliance report in respect of shortcoming as mentioned above must be submitted.
